BYLAW CHANGES APPROVED

Shareholders were asked to vote for bylaw changes with proxies that were mailed out in early November 2019.

We are pleased to report that all the requested changes were passed. Bylaw changes include the following:

- It is no longer a requirement for members to be a "resident" of California. The wording has changed to "doing business in California". Therefore, any business that purchases from CALAMCO outside of California is now eligible to own stock in CALAMCO. This helps maintain the value of stock by creating broader access for stock ownership.
- 2. CALAMCO can request members sell their stock if they do not report fertilizer use for 3 or more years. Per our bylaws, you must use anhydrous ammonia or products containing anhydrous ammonia in order to qualify for stock ownership (otherwise there is no benefit to owning stock). CALAMCO will notify members that do not report fertilizer use for 3 or more years (bylaws used to read 5 years or longer). This gives us the ability to "clean up" inactive membership and provides significant cost savings.
- 3. Two additional changes determine what constitutes a quorum at Board of Director meetings. Specifically, it used to be that a majority of Class A & B directors combined be present. Bylaws now specify that a majority each, Class A directors (3 out of 4), and a majority of Class B directors (2 out of 3), must be present. ■

2019 FINANCIAL RESULTS

Rebate checks were mailed to participating members in January for our 2019 fiscal year. We paid out a dividend of \$41.49 per ton of ammonia equivalent.

An additional \$1 per ton was paid to those members that reported their annual fertilizer purchases using our online access portal instead of physically mailing a fertilizer use report form. With this incentive, online reporting increased from 33% in 2018 to 65% this past year.

Another additional \$1 was paid to those members that opted for direct deposit for their dividend. Growers signing up for direct deposit grew from 9% in 2018 to 51% in 2019. Growers that opted for both realized a dividend of \$43.49. A return on investment of 33% for stock purchased at \$20 per share. ■

Though our rebate per ton is based on a per ton of Anhydrous Ammonia (NH₃ equivalent) basis, we are often asked what that means when broken down by specific products.
