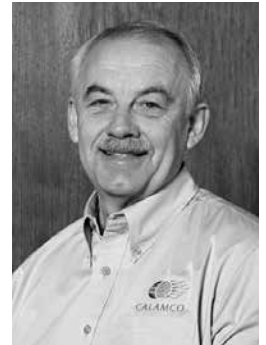
MESSAGE TO SHAREHOLDERS

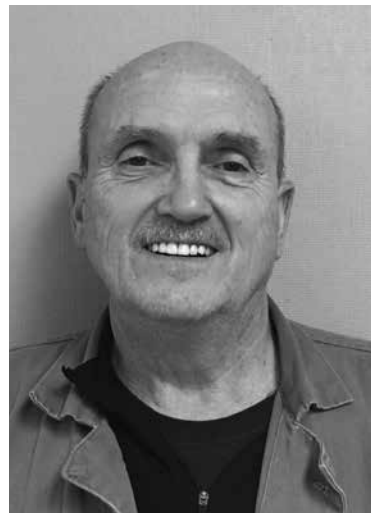
A PARTNERSHIP WITH GROWERS

The decision to branch out into the trucking business, and purchase our own anhydrous ammonia tractor-trailers was made by our management and board of directors in 1986. The first two truck and trailer sets were purchased, and four drivers were hired to run the trucks on a round-the-clock-rotation. Larry Luis was one of those initial four drivers hired, and thus, on January 5, 1987 began his 30 plus year career with CALAMCO.

Around the same time, CALAMCO decided to create our anhydrous ammonia safety training program, which, in it's infancy, included a mobile classroom that we would haul around the state providing safety training to customers. Since a Class A license was required to haul the mobile classroom/trailer, Larry was recruited from hauling anhydrous ammonia to driving the trailer around various parts of the state for safety training purposes. He eventually went back to hauling anhydrous ammonia, and after approximately 10 years, moved to working at the Stockton terminal, becoming a loader, and eventually a lead-man. Larry could always be counted on when it came to covering relief and vacation shifts.

Born September 1952 in Fort Lennardwood, Missouri on a military base, Larry has three younger brothers (one resides in Alaska and two in Modesto) and a sister that resides in Riverbank. His dad left the military soon after Larry was born and moved their family to Ferndale, CA. Larry was eleven when they ended up in Modesto. One of his first jobs when he was still in school was working for Payless Drug Store, where he stayed for about 5



years becoming a department manager. He then went to work for a feed company in Ceres where he received his first experience driving a truck. He decided to purchase his own truck in 1982, becoming an owner/operator, hauling liquid sugar into the port of Stockton. He used to weigh his truck at the CALAMCO terminal, and, as they say... the rest is history.

Larry loves the outdoors; hunting, fishing, camping etc., and purchased a home in Tuolumne a few years ago. He recently sold his home in Stockton, and has permanently moved to his "retirement" home in the mountains. He is looking forward to relaxing with his morning coffee, and evening glass of wine on his deck, enjoying the beautiful scenery.
