MESSAGE TO SHAREHOLDERS

We will soon be asking you to vote YES on amending CALAMCO's Bylaws with regard to shareholder voting rights.

We recently learned our process of voting based on total share ownership is not in compliance with IRS' requirements for cooperatives enjoying the benefit of being taxed under Subchapter T of the Internal Revenue Code. This benefit amounts to an approximate \$2 million annual tax savings.

Currently, we count votes based on the number of shares owned; however, the IRS only allows either one vote per shareholder, or voting based on actual usage by the shareholder. The Board of Directors recommends voting based on actual usage – and will submit a proposed Bylaw amendment to accomplish this change in voting method for your approval.

We are happy to report the completion of a healthy spring season, as our shipments were stronger than expected. We remain on track to deliver our \$55 per ton patronage rebate target for the 2025 fiscal year. Lower ammonia prices helped offset the new 10% tariffs from Trinidad.

The end of the spring season also marked the retirements of long-time employees Alice Inderbitzin and Dale Thigpen. Alice served in Sales & Marketing since being hired in 1985 and Dale was in various Operations positions after his original hiring in 1976. We will miss them both.
